General Conditions of Contract

1. Scope of Contract

This Contract shall include all such items, although not specifically mentioned, that can be reasonably inferred as being required for its completion as if such items were expressly mentioned herein. All the provisions of RA No. 9184 and its 2016 revised IRR, including the Generic Procurement Manual, and associated issuances, constitute the primary source for the terms and conditions of the Contract, and thus, applicable in contract implementation. Herein clauses shall serve as the secondary source for the terms and conditions of the Contract.

This is without prejudice to Sections 74.1 and 74.2 of the 2016 revised IRR of RA No. 9184 allowing the GPPB to amend the IRR, which shall be applied to all procurement activities, the advertisement, posting, or invitation of which were issued after the effectivity of the said amendment.

Additional requirements for the completion of this Contract shall be provided in the **Special Conditions of Contract (SCC)**.

2. Advance Payment and Terms of Payment

2.1. Advance payment of the contract amount is provided under Annex “D” of the revised 2016 IRR of RA No. 9184.

2.2. The Procuring Entity is allowed to determine the terms of payment on the partial or staggered delivery of the Goods procured, provided such partial payment shall correspond to the value of the goods delivered and accepted in accordance with prevailing accounting and auditing rules and regulations. The terms of payment are indicated in the **SCC**.

One Year Supply and Delivery of Compressed Air, Medical Oxygen (Std), Carbon Dioxide, Nitrous Oxide and Medical Flask Oxygen

1. Delivery

- 1.1 The supplier shall ensure continuous delivery without charges incorporated to the delivery of all medical gas tanks and flasks for the period of January 1, 2021 to December 31, 2021.
- 1.2 The hospital shall place an order with its quantity thru Delivery Order Sheet (DOS) every Monday and Thursday through the Procurement Section or the Authorized Sterilization Room Staff during Saturdays, Sundays, or holidays as the need arise
- 1.3 The schedule of delivery shall be every Tuesdays and Fridays at 9:00 am – 11:00 am.
- 1.4 If the scheduled delivery falls on a holiday, the delivery schedule maybe moved the day before or after the holiday, at the option of PCMC.
- 1.5 The supplier shall deliver shall deliver the loaned cylinders to the main stock room located below the ramp and at the second floor.
- 1.6 The supplier shall comply to Standard Operating Procedures for safety and proper handling management of cylinder during delivery.

2. Quantity for Delivery

- 2.1 The supplier shall provide an initial delivery of 150 cylinders of medical oxygen (STD) and 70 cylinders of compressed air.
- 2.2 All cylinders (regular and flask type) owned by the hospital shall be refilled as needed and as requested by Sterilization staff. The filled cylinders shall be returned on the next delivery schedule.
- 2.2 Quantity to be delivered shall depend on the current actual utilization in the hospital.

3. Required Tests

- 3.1 The supplier shall submit the delivered cylinders for measuring of its gas contents in pounds per square inch (PSI). Each cylinder shall contain a minimum standard of at least;
 - 3.1.1 One thousand eight hundred (1,800) PSI for oxygen and compressed air
 - 3.1.2 Eight hundred thirty five (835) for Carbon Dioxide (average gas content 22.57 kg)
 - 3.1.3 One thousand (1000) PSI for Nitrous Oxide (average gas content 22.57 kg)

- 3.2 The hospital flow meter gauge shall be used to measure the gas content. This shall be done in the presence of the supplier's authorized representative, hospital representative from Property and Supply, Pre-Audit, and Sterilization Room or NSO Nursing Attendant.
- 3.3 The percentage of air purity of delivered oxygen cylinders must be tested by the Supplier and a written report must be submitted quarterly to the hospital through Property and Procurement. The hospital shall randomly conduct testing for air purity on the delivered cylinders. For every cylinder found below the standard air purity, cost of cylinder plus 25% surcharge shall be deducted from the payment due to the supplier.

- 4.3 The serial numbers on the cylinders delivered should be clearly embossed and readable. The serial numbers shall be written on the sales invoice.

- 4.5 The supplier shall submit certificate of testing to ensure that the high pressure cylinder are calibrated & fire safe to use.
