- 2.1. The GOP through the source of funding as indicated below for CY 2021 in the amount of Nine Million One Hundred Thirty Two Thousand Two Hundred Fifty Four Pesos (Php 9,132,254.00)
- 2.2. The source of funding is:
 - a. GOCC and GFIs, the Corporate Operating Budget.

3. Bidding Requirements

The Bidding for the Project shall be governed by all the provisions of RA No. 9184 and its 2016 revised IRR, including its Generic Procurement Manuals and associated policies, rules and regulations as the primary source thereof, while the herein clauses shall serve as the secondary source thereof.

5. Eligible Bidders
