TERMS OF REFERENCE

Preventive Maintenance Services of C-ARM, Veradius Unity (Property No. 1608-419-1432-A-SUR)/ SN# 268

In connection with the service contract, the following scopes shall be included prior to start of the agreement.

Scope:

Semi Annual Preventive Maintenance schedule:

- 1.1 March 2023- 1st PMS.
- 1.2 September 2023 -2nd PMS
- 2. Equipment Maintenance include: Value (Labor Only)
 - A. Two (2) times per year Planned proposal as per manufacture's standards. This shall consist of the systemic and routine inspection and adjustment carried out on the system at regular intervals in order to keep the system within specification.
 - B. Unlimited Corrective Maintenance. This shall consist of the performance of all acts necessary to bring the system to good working order, which will include calibration, repair and /or replacement of parts. This corrective maintenance shall be performed at your request during regular working hours
 - C. In the performance of the planned Maintenance And Corrective Maintenance, All Parts That will be required to be replaced shall be furnished by Philips Charge to be account of the customer upon issuance of Purchase Order.
 - D. System performance software and hardware updates are free of charge. This does not include system upgrade.

E. Technical Phone support:

- a. Phone support: 4 hrs. Initial and onsite response
- b. Response time: within 24 hours from the receipt of request for service
- c. PMS and corrective repair: 8:30 am to 5:30 PM from Monday to Friday.
- F. Supplier shall submit complete Semi- Annual preventive maintenance checklist and annual certificate of calibration.
- G. Service engineer and application specialist must submit certificate of training.

H. Supplier shall use calibrated biomedical analyzers to check test and maintain the unit calibration certificate must be submitted
