- 1. Bidders were advised to verify calls received from anyone or any organization that uses the name of Dr. Julius A. Lecciones, Executive Director of this Medical Center, to solicit financial support for certain projects for those transactions are never legitimate nor authorized.
- 2. Engr. Enrique Cortez as the Project Consultant from ORRA stated:
 - a. That this project is challenging because hospital operation must not be disrupted by the renovation. It is the reason why the implementation of this project has to be by phasing. Before we start in every phase we have to seek clearance from our Engineering Office.
 - b. That the temporary facility for the workers will be off site or a small house within the area if the Winning Bidder will be different from those already with on-going projects with PCMC. There is no more available space due to several on-going infrastructure projects in this Medical Center.
 - c. IATF Protocols must be strictly followed.
- 3. Bidders were reminded not to forget the Total in there list of on-going projects.

There having been no other remaining topics for discussion, the pre-bid conference adjourned at 11:45A.M.
