GENEVER M. DIONIO, as EVIDENCED BY Special Power of Attorney dated 16 December 2022.

PCMC AND JDLC are hereinafter collectively referred to as the "parties."

WITNESSETH, that:

WHEREAS, PCMC is desirous for the execution of One (1) Lot Supply of Labor and materials for the Construction of PCMC's New 8-Storey Building with Basement Phase 1 (Take Over) under Request for Quotation No. RFQ-NAC-2022-076 (hereinafter called "the Works") and PCMC has accepted the Bid of the CONTRACTOR for One Hundred Eighty-Seven Million Nine Hundred Ninety-Nine Thousand Nine Hundred Ninety-Eight Pesos and 58/100 (PhP187,999,998.58) for the execution and completion of the Works and the remedying of any defects.

TERMS AND CONDITIONS

- 1. In this Agreement, words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract hereinafter referred to.
- 2. The following documents as required by the 2016 Revised Implementing Rules and Regulations of Republic Act No. 9184 shall be deemed to form and be read and construed as part of this Agreement:
 - a. Negotiated Procurement Documents (NPD):
 - i. Drawings/Plans
 - ii. Specifications
 - iii. Bill of Quantities
 - iv. General and Special Conditions of Contract
 - v. Supplemental or Bid Bulletins, if any
 - b. Contractor's offer, including the eligibility requirements, technical and financial proposals, and all other documents or statements submitted;
 - c. Performance Security;
 - d. Notice of Award of Contract and the Contractor's conforme thereto; and
 - e. Other contract documents that may be required by existing laws and/or the Procuring Entity concerned in the NPDs. <u>J.D. Legaspi Construction</u> agrees that additional contract documents or information prescribed by the GPPB that are subsequently required for submission after the contract execution, such as the Notice to Proceed, Variation Orders, and Warranty Security, shall likewise form part of this Agreement.

- 3. In consideration for the sum of One Hundred Eighty-Seven Million Nine Hundred Ninety-Nine Thousand Nine Hundred Ninety-Eight Pesos and 58/100 (PhP187,999,998.58), J.D. Legaspi Construction agrees to execute One (1) Lot Supply of Labor and materials for the Construction of PCMC's New 8-Storey Building with Basement Phase 1 (Take Over) in accordance with their Bid.
- 4. PCMC agrees to pay the above-mentioned sum in accordance with the terms of the Negotiation.
- Pursuant to Section 3 of Executive Order (EO) 398, the CONTRACTOR covenants to pay its taxes
 in full and on time. Failure to do so will entitle the PCMC to suspend payment for any goods or
 services delivered.
