WHEREAS, the Entity invited Bids for certain goods and ancillary services, particularly **PROCUREMENT OF ONE (1) LOT LAUNDRY SERVICE FOR THREE (3) YEARS** and has accepted a Bid by the Supplier for the supply of those goods and services in the sum of **THREE MILLION ONE HUNDRED NINE THOUSAND FOUR HUNDRED TWENTY-ONE PESOS AND 94/100 (PhP3,109,421.94)** per year (hereinafter called "the Contract Price").

### NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

  - ii. Winning bidder's bid, including the Eligibility requirements, Technical and Financial Proposals, and all other documents or statements submitted;
  - Bid form, including all the documents/statements contained in the Bidder's bidding envelopes, as annexes, and all other documents submitted (e.g., Bidder's response to request for clarifications on the bid), including corrections to the bid, if any, resulting from the Procuring Entity's bid evaluation;
  - iii. Performance Security No. ORASCO Bond No. G (13) 012615;
  - iv. Notice of Award of Contract No. NOA-2022-046; and the Bidder's conforme thereto; and
