WHEREAS, the Bids and Awards Committee Office received the approved Purchase Request (PR) No. GSD-House-2023-02 for the purchase of the following:

WHEREAS, on November 16, 2022, the Pre-Procurement was conducted at the Procurement Division's Conference Room where the PR No. GSD-House-2023-02 was returned to the end-user for possible amendments;

WHEREAS, on November 23, 2022, the Bids and Awards Committee issued the Invitation to Bid No. IB-2023-020 for the above-mentioned item and posted it through PHILGEPS (Reference No. 9267066), PCMC Website and conspicuous places. Moreover, the BAC Secretariat made invitations through phone calls;

WHEREAS, on December 1, 2022, the Pre-bid Conference was held via Video Conference (Zoom) and was attended by the following prospective bidders:

1. Jong and Jacob Pest Control
2. Power House Pest Control Services

WHEREAS, the Bids and Awards Committee issued Bid Bulletin No. BB-2023-011 that outlined amendments in the requirements and bidding documents (see attached);

WHEREAS, only CERTICON - Certified Pest Control Services purchased the bidding documents;

WHEREAS, on December 13, 2022, the scheduled submission and opening of bids, the result is as shown in the attached Matrix of Bid Opening;

WHEREAS, the TWG conducted the required post-qualification process to CERTICON = CERTIFIED PEST CONTROL SERVICES being the Single Calculated Bid;

WHEREAS, upon examination, validation, and verification of all the technical and financial component requirements submitted by the bidder with the Single Calculated Bid in the Post-Qualification Evaluation Summary Report, its bid has been found to be responsive by the TWG and the BAC;

NOW, THEREFORE, We, the Members of the Bids and Awards Committee, hereby RESOLVE as it is hereby RESOLVED:






