PHILIPPINE CHILDREN'S MEDICAL CENTER a government-owned and controlled corporation with office address at Quezon Avenue corner Agham Road, Quezon City, represented by its Executive Director, SONIA B. GONZALEZ, MD, MScHSM, MPM, as evidenced by Board Resolution No. 2022-8-15-01R dated March 24, 2022, hereinafter referred to as "PCMC";

- and -

PRC COURIER AND MAINTENANCE SERVICES, a sole proprietorship duly organized and existing under and by virtue of the laws of the Philippines, with principal address at 727 Ballesteros St., Cor. Boni Avenue Mandaluyong City, represented by the Proprietress, JOYCELYN C. WANG, duly authorized under the Omnibus Sworn Statement and Secretary's Certificate (Annex "A"), hereinafter referred to as the "SUPPLIER".

WHEREAS, PCMC is desirous for the execution of One (1) Lot Janitorial and other Utility Services (Multi-year) for three (3) years under Invitation to Bid No. IB-2023-013 (hereinafter called "the Works") and PCMC has accepted the Bid of the SUPPLIER for Twenty-Three Million Seven Thousand One Pesos and 49/100 (PhP 23,007,001.49) for the first year, hereinafter called "the Contract Price" for the execution and completion of such Works and the remedying of any defects therein.

## NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

- 1. In this Agreement, words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract hereinafter referred to.
- 2. The following documents as required by the 2016 Revised Implementing Rules and Regulations of Republic Act No. 9184 shall be deemed to form and be read and construed as part of this Agreement, to wit:
  - (a) Philippine Bidding Documents (PBDs):
    - i. Schedule of Requirements;
    - ii. Technical Specifications;
    - iii. General and Special Conditions of Contract; and
    - iv. Supplemental or Bid Bulletins, if any
  - (b) Winning bidder's bid, including the Eligibility requirements, Technical and Financial Proposals, and all other documents or statements submitted;
    - Bid form, including all the documents/statements contained in the Bidder's bidding envelopes, as annexes, and all other documents submitted (e.g., Bidder's response to request for clarifications on the bid), including corrections to the bid, if any, resulting from the Procuring Entity's bid evaluation;
  - (c) Performance Security No. The Premier Insurance & Surety Corporation G(13) 115579
  - (d) Notice of Award of Contract No. NOA-2023-021; and the Bidder's conforme thereto; and

- (e) Other contract documents that may be required by existing laws and/or the Procuring Entity concerned in the PBDs. <u>The Supplier</u> agrees that additional contract documents or information prescribed by the GPPB that are subsequently required for submission after the contract execution, such as the Notice to Proceed, Variation Orders, and Warranty Security, shall likewise form part of the Contract.
- 3. In consideration for the sum of Twenty-Three Million Seven Thousand One Pesos and 49/100 (PhP 23,007,001.49) for the first year which will commence on May 16, 2023, 2023 or such other sums as may be ascertained, PRC COURIER AND MAINTENANCE SERVICES agrees to execute One (1) Lot Janitorial and other Utility Services (Multi-year) for three (3) years in accordance with its Bid.
- 4. PCMC agrees to pay the above-mentioned sum in accordance with the terms of the Bidding.
