President Ferdinand R. Marcos, Jr., visited the Philippine Children's Medical Center (PCMC) on September 10, 2024, to celebrate Childhood Cancer Awareness Month with brave children battling cancer.

Every September, PCMC joins the world in observing "Childhood Cancer Awareness Month" to raise awareness, support research, and improve treatment for pediatric cancer.

During the event, the PCMC 20-storey Legacy Tower project was also presented to the President. It shall have a 500-bed capacity tertiary hospital with a mandate "to provide pediatric care, offer training programs for medical, nursing, and allied health care providers, and be a center of clinical research". It shall offer a wide array of general and subspecialty services in pediatrics, surgery,

and allied medicine.

The President also conducted a tour and inspection of the newly installed 128-slice computed tomography (CT) scan, MRI, and Dynamic DR X-ray machines with Health Secretary Teodoro Herbosa and PCMC Executive Director Sonia B. Gonzalez.

Furthermore, President Marcos, Jr., turned over a check donation amounting to PhP150 million for upgrading the hospital's equipment.

Before the event concluded, the patients and the rest of the audience sang a birthday song for the President. Quezon City Mayor Joy Belmonte and DPWH Secretary Manuel Bonoan were also present during the event.

# PCMC officially receives its PRIME-HRM Maturity Level 2 recognition from the Civil Service Commission

After complying with the necessary evidence requirements, the agency underwent the assessment process last March 19-21, 2024, by four (4) validators from the CSC. On their last day, the validators happily announced their recommendation for PCMC as PRIME-HRM Maturity Level II.

HRMD Head Mr. Dimaala addressed the community with gratitude and pride, emphasizing that "with the strong support of top management together with the whole community, PCMC successfully passed the 3-day assessment of all HRM systems."

"With the continued support of all employees, partners, and heads, PCMC is geared to achieve even more significant milestones for the next level of PRIME-HRM," said Executive Director Gonzalez.

# The PCMC Journal is Now Accessible on the Philippine E-Journal Portal



The Healthcare Library Section (HLS) is excited to announce that The PCMC Journal is now available on the Philippine E-Journal (PEJ) Portal, providing open access to Volume 19, Issue No. 1 (2023) and Volume 20, Issue No. 1 (2024).

This achievement was made possible after PCMC Executive Director, Dr. Sonia B. Gonzalez, approved the proposal to join PEJ as a research contributor. The initiative came from the HLS team under the leadership of Clinical Trial and Research Division (CTRD) Head Dr. Ma. Lucila M. Perez, which was eventually endorsed by Clinical Research Department (CRD) Department Manager Dr. Caridad M. Santos and Deputy Executive Director for Education Training and Research Services (ETRS) Dr. Mary Ann C. Bunyi. Upon approval, an online meeting with the PEJ team took place on November 17, 2023, and the Memorandum of Agreement (MOA) had been drafted by November 20, 2023.

After reviewing the draft MOA on May 14, 2024, the PEJ team provided its final version without the watermark, then had the contract sent to CE-Logic, PEJ's parent company. This step was critical for the strategic deliverables of PCMC-HLS and was discussed during the ETRS Annual Strategy Refresh meeting on June 26, 2024.

Much to the delight of the CTRD staff, following notarization of the MOA and an orientation via Zoom, the journal submissions finally began during the last week

of July. By August 12, 2024, PEJ notified the PCMC-HLS that the subscriptions were successfully uploaded.

As a contributor, PEJ offers PCMC-HLS free hosting for its publications, regular performance analytics, and developmental support for journal growth. Meanwhile, PEJ subscribers can now access The PCMC Journal both onsite and offsite, utilizing PEJ's remote access feature.

The inclusion of The PCMC Journal on the PEJ portal enhances PCMC's ability to disseminate essential pediatric and perinatal research, reaching a wider audience both locally and internationally.

## Training on RA 9184 and its 2016 **Implementing Rules and Regulations**

In its effort to promote good governance, the Procurement Division under the Administrative Services Department spearheaded a comprehensive three (3)-day training on Republic Act No. 9184 and its 2016 Revised Implementing Rules and Regulations (IRR) from August 12 to 14, 2024.

This activity is in compliance with the Government Procurement Policy Board's (GPPB) thrust to establish a sustained training program to develop the capacity of the Bids and Awards Committee (BAC), the BAC Secretariat, the Technical Working Group, and end-users involved in the procurement process.

The training commenced with the opening remarks from Executive Director Dr. Sonia B. Gonzalez, who is instrumental in driving PCMC's commitment to excellence. She stated that it is important for everyone "to learn and understand the procurement law because it is the foundation of the procurement process."

Executive Director Gonzalez reminded the Technical Working Group and the different end-user units "to do their complete staff work in coming up with the right price for all items the units need to buy." She emphasized that those involved in procurement should consider honesty and integrity in all their dealings. Lastly, she said that procurement is of great importance because it directly affects the delivery of health services to clients, PCMC's operational efficiency, and financial management.

The resource speakers were GPPB-recognized trainers on the procurement law led by Atty. Karina Antonette A. Agudo, Director IV of the Administrative Service of the Department of Social Welfare and Development. She covered topics including "Government Procurement 101" and "Procurement Planning and Budget Linkage, Early Procurement Activities."

On the second day of the session, Engr. lan T. Fajarito, Chief Administrative Officer of the General Services Division of the Anti-Red Tape Authority, guided the attendees through "Standard Bidding Procedures," "Protest Mechanism and Blacklisting Guidelines," as well as the "Penal, Civil, and Administrative Provisions of RA 9184."

The last day of the training was managed by Ms. Ma. Celeste S. Dizon, Supervising Administrative Officer of the Philippine Competition Commission. Ms. Dizon's sessions focused on the "Alternative Methods of Procurement," the "Framework Agreement," and "Green Public Procurement."

The speakers' depth of knowledge, extensive experience, and standpoints have given the participants much to reflect on further enhancing PCMC's procurement process.

These sessions were followed by an open forum, allowing the lively exchange of ideas where participants actively engaged in the discussions, seeking clarifications and expanding their understanding of the topics presented. The insights shared have truly enriched everyone's knowledge on the procurement law.

Overall, the three-day event successfully equipped PCMC personnel with a deeper understanding of RA 9184 and its 2016 Revised IRR, fostering a stronger resolve to transparency, efficiency, and accountability in government procurement. Their presence and enthusiasm have truly made the event a success.
